DKG MD State Finance Committee

Christy Mullins, Alpha Beta, State Finance Committee Chair

The 2023-2024 DKG MD State Finance Committee met four times over Zoom to 2024-2025 prepare the budget, ensure oversight of the spending of DKG funds, and assist the State President in reviewing the Treasurer's performance for the past year. Current Finance Committee members include: Christy Mullins (Chair), Alpha Beta; Sheila Owens, Mu; and Gretchen Ginder, Zeta. Maryland State President DKG Nazelrod, Xi, and DKG Maryland State Treasurer Mary Louise (Weezie) Carey, Alpha Delta, serve as ex-officio members. DKG Maryland State Executive Secretary Gwen Cooley, Delta, serves as a consultant. All members consultants and are to commended for their dedication, time, and effort in making thoughtful decisions for and being good stewards of the finances of DKG Maryland.

One topic of clarification the Finance Committee would like to share is distinction between scholarships and grantsin-aid. At the end of each fiscal year, each chapter treasurer completes Form 15, which asks how much money has been awarded for grants-in-aid and scholarships by the chapter. Although both award money to individuals for educational purposes, the important difference is who receives the money. If a chapter member receives the award, then it's considered a scholarship. If a non-member (such as a high school or college student) receives the award, then it's considered a grant-in-aid. These are the definitions used by International.

State and local chapters are allowed to call their awards whatever they like, as long as the monies awarded are correctly categorized as grants-in-aid or scholarships on Form 15. If you serve as a state officer or committee chair, keep an eye out for new PDF fillable forms for Request for Reimbursement. The Finance Committee has created an electronic form that can be filled out and emailed to the State President when requesting reimbursement instead of filling out the triplicate form and mailing it. Hopefully, this new electronic process will save everyone time and money on postage.

If you'd like to get more involved at the state level, the Finance Committee currently has a vacancy. Please contact Nominations if you are interested in serving. Members meet over Zoom in the evenings about five times a year and do their best to schedule meetings that work for everyone.

Lastly, their current treasurer has expressed interest in passing the torch to someone new. Please carefully consider whether you may be interested in serving as DKG MD State Treasurer for the 2025-2027 biennium.

Chapter Support Suggestions

The next biennium is right around the corner. When crafting your slate of officers, Chapter Support would like each chapter to think about new and different ways to organize your Executive Board and chapter structure. Historically, each chapter has had a President and 1st and 2nd Vice President. Recently, some chapters have started crafting new ways to run the chapter and use the strength of each member.

Pieces to think about:

- **Co-presidents** A chapter can have two presidents and organize a co-sharing arrangement. Sharing the responsibilities can help lighten the workload and enable two people to bounce off ideas and help organize chapter events.
- Chapter meetings/activities The person in charge of meetings and gatherings can be rotated among chapter members. Not one person is solely responsible for and has to run every event. For example, different members can be in charge of meetings with the president updating and distributing any state or international information. In essence, state and international members communicate with the president, so the president can disseminate this information and chapter members can take turns running meetings, finding guest speakers, and creating activities. Each chapter member has a strength and can contribute to the running of the chapter.
- Multi-president committee With this committee of three to four people, the chapter needs one person to receive information from state and international, but the group can work together to organize meetings and chapter events. Instead of one person, a small group is in charge. In essence, this committee works as a team to get things done.

Our chapters love working together. We help each other, and all of us have strengths to contribute. To be healthy, we need to use our strengths, celebrate our successes, and work as a community. Delta Chapter's Outreach in Zambia

Many years ago, *Jeannie Niebel* visited the Ngombe Township in Zambia. She found profound poverty and asked how to help. The answer was through education. That was the beginning of collecting books and shipping them to Zambia. Then there was a need for money to send the books. Then a need to house the books in a library. Then a need for schoolrooms. Then a need to feed the children at lunch. Then a need to hire and pay teachers. Then a need for Z-pads (tablets) and charging stations. Then a need to train teachers in the best practices of teaching. Then a need to upgrade the library. Then a need to repair the buildings and so on.

Along the way, Jeannie and *Diane Straub* have written grants to fund the school (Good Shepherd School) and gotten two grants from Delta Kappa Gamma International for a library and Z-pads. Delta Chapter has also donated money at the holidays for books, Z-pads, and teacher salaries.

Today, Good Shepherd School has about 135 students and five teachers. There are three classrooms, a kitchen, and a large library. They partnered with non-profit IMPACT ONE, which helps a small number of schools to improve instruction and deal with finances.

The teachers are happy and highly motivated, receiving superior training and getting paid \$100 monthly on time.

The Adda Clark Library, named after Delta member *Adda Clark*, has a large stock of books, the exact number of which will be known soon. They have added software and a scanner to check books in and out. The Good Shepherd students and many students from the region utilize the library for classroom space and pleasure reading.

What does Good Shepherd School need? They continue to need money to maintain facilities, pay teachers, buy nutritious porridge for lunch, and send a few exceptionally bright students to high school for \$300 per year.

With this long history in mind, I'd like to reestablish our generous giving to the Good Shepherd School in Zambia. Their needs are many, but their impact is great for the children of Zambia.
